The above jobs are subject to the following conditions:

- 1. The rates should be inclusive all the charges and taxes i.e. Service Charge, VAT etc.
- 2. The amount quoted by the firm and accepted by MDNIY will be final for the contract period of one yea. No other charges/increase in rates will be acceptable to MDNIY at a later date, in any case. The firm should give the rates for a further period also.
- 3. The firm must enclose their experience reference for the last three years.
- 4. If there is any damage during the treatment, same shall be recoverable from their bill and for any quality defects in providing Pest Control Treatment, the responsibility lies with the firm.
- 5. The Earnest Money of Rs.6,000/- (Rupees six thousand only) for the Pest Control Service for one year may be enclosed with the quotation separately in favour of Morarji Desai National Institute of Yoga, New Delhi through Demand Draft/Pay Order only.

- 6. The EMD amount of the successful bidder will be converted in the Performance Security which will be retained during the contract period. The Performance Security will be 5% of the contractual value of any additional amount over and above the EMD will have to be deposited by the successful bidder and will be refunded after satisfactory completion of the contract period.
- 7. The firm who have quoted the rates and are successful in getting the award of contract but are unable to accept the contract due to any reason, their EMD will stand forfeited.
- 8. Bidder should affix their firm's completed seal duly waxed/taped alongwith signature on envelops cuts.
