The Sealed Technical quotation/ bid with the EMD amounting to Rs. 5,000/-(Rupees Five Thousand Only) in favour of "Morarji Desai National Institute of Yoga" through Bank Draft/Pay Order only with supporting self attested documents like copies of PAN, TAN, Registration Certificate, Service Tax No. Audited Statement for the last year ending of 31st March 2016, Statement of client Ministries/Departments, to whom the material has been supplied during 2015-16 & 2016-17 (till 31st December 2016) in one envelope & Financial bid separately in the envelope, for both categories of T-Shirts at (i) & (ii) of the table above, shall be placed in a third envelope and will be submitted addressed to the Director, Morarji Desai National Institute of Yoga (MDNIY), super scribing on the top of envelop as "Quotation for

supply of Printed T-Shirts in MDNIY" should reach this office latest by 23.01.2017 upto 11.00 am.

- 2. The quotations will be opened on the same date at 11.30 am in the presence of the bidder(s) or their nominated/authorized representative, if present.
- 3. Quotations received after closing date and time will not be entertained
- 4. The Financial Bids of only those bidders shall be opened on the same date and time after opening the Technical Bids or a later date & time as may be decided and intimated by MDNIY, whose Technical Bids stand qualified and admitted as per MDNIY specimen & specifications given above. The decision of MDNIY shall be final in this regard.
- 5. The prospective bidder(s) who must be registered/empanelled with any Ministry/Department of the Govt. of India at New Delhi or NCT, Govt. of Delhi is/are requested to first visit & see the colour, specimen, design & finishing of the T-Shirt, available in MDNIY before submitting the bid, during all working days from 10 am 05 pm except closed holidays till 20.01.2017.
- 6. After checking the T-Shirt in MDNIY, the bidder shall submit the specimen meeting with complete specifications, colour and design etc. of the T-Shirt, duly stitched, alongwith the Technical Bid /quotation letter with EMD without which the quotation will not be entertained and considered.
- 7. The firm which has quoted the lowest rates and are successful in getting the award for printing of T-Shirt with material but are unable to accept the contract due to any reason, their EMD will stand forfeited.
- 8. The approved rates, inclusive of creative designing, stitching and delivery at door step etc., will be valid for a period of one year from the date of issuance of the work order including supply of additional quantity of the T-Shirts at a later date, on the same rates, terms & conditions as may be decided by the MDNIY.
- 9. The institute reserves the right to accept or reject any quotation without assigning any reason thereof.
- 10. All the disputes shall be subject to Delhi Jurisdiction only.
