Morarji Desai National Institute of Yoga would like to conduct 36 hours Yoga Volunteer programme for the general public as part of the Azadi ka Amrit Mahotsav. It is expected to train 1.5 lakh people by June, 2022.

For this, the applications are invited from the Yoga Instructors who have passed the Yoga Protocol Instructor course or equivalent with Level -1 Yoga Certification Board (YCB) Certificate for preparing a panel. The general guidelines for the Yoga Instructors are as under:

- 1. The Yoga Instructors are to train minimum 50 people in their area or the place where they will be deputed.**
- 2. The Training will be of one month duration (36 hours)**
- 3. The training will be either offline or hybrid mode or online, depending upon the situation.**
- 4. The Instructors will be paid a monthly remuneration of Rs. 6,000/- for a batch of 50 people. If they conduct the training for more than 50 people, the remuneration will be provided accordingly (i.e. on pro-rata basis).**
- 5. The remuneration will be paid only after successful completion of the course by the participants.**
