Note:

- 1. The engagement shall be purely on temporary contract basis on a fixed remuneration initially for a period of one year and is likely to be curtailed or extended on performance basis or until the project lasts.

- 4. The selected candidates have to work in Yoga Therapy Centres run by the Institute in different Govt. Hospitals in Delhi NCR.
