# Guidelines for Registration as a YogFluencer

## 1. Criteria for being a Yogfluencer:

- (i) The applicant individual needs to be present on at least one social media platform (Facebook, X, YouTube or Instagram)
- (ii) The individual must have at least 10,000 followers on their social media platform. The individual should be a health and wellness enthusiast, and he/she should be willing and ready to post Yoga related content on his/her social media handles by using hashtag promoted by Ministry of Ayush.

The hashtags presently being promoted are #IDY2025, #YogaForOneEarthOneHealth #InternationalDayofYoga2025 and #InternationalDayofYoga . These may change from time to time, as notified by the Ministry.

- (iii) The applicant individual should be willing to tag MDNIY & Ministry of Ayush official social media handles in Yoga related content created by the Yogfluencer
- (iv) The individual organizes/participates in MDNIY (Morarji Desai National Institute of Yoga)
- (v) & Ministry of Ayush on-ground/virtual events wherever possible.
- (vi) The individual must be following social media handles of MDNIY & Ministry of Ayush.

#### 2. Requirements for being a Yogfluencer:

The individual has not been punished for any criminal offence.

Any Criminal legal proceedings shall not be pending against the individual

The selected/ nominated individual shall always act in compliance with the rules/regulations/guidelines mentioned on the website of MDNIY & Ministry of Ayush.

The decision of selection process will be done by MDNIY & Ministry of Ayush, and it shall be final.

The selected/ nominated individual, in his/her posts associated with MDNIY & Ministry of Ayush, shall not include content/text/pictures which may be offensive and hurt sentiments of any religion, caste, gender and sexuality.

The initial period of association will be for a period of one year, subjected to renewal based on discretion of MDNIY & Ministry of Ayush.

MDNIY reserves the right to terminate the association at their discretion at any point of time during the association in public interest, without giving any reasons.

### 3. Deliverables of MDNIY:

Recognition as Yogfluencer on official website of MDNIY.

Recognition as Yogfluencer on official social media handles of MDNIY & Ministry of Ayush.

Promotion of Yoga-related content created by Yogfluencer on MDNIY & Ministry of Ayush Official social media handles.
